Economic Stall Strategy

The Honolulu Blenders are engaging in a two-part “stall strategy” in an effort to delay reform of the current “10% Blend” law. They argue there should be no labeling reform without a “study” and also that the State can’t afford to spend the money to do a study.

The Hawaii Department of Agriculture agrees - the HDoA can’t afford \$200,000 (the UH-CTAHR proposal) or \$98,000 (the Farm Bureau proposal) studies.

But wait! Is there a solution offered? Marvin Feldman, Ph.D, a resource economist and a Captain Cook coffee farmer, has sent a letter to the HDoA stating that an economic study of the affects of changing the Kona Blend minimum to 50% could be done for less than \$25,000, and that his firm, Resource Decisions, would do an economic study for that amount.

As Dr. Feldman succinctly states in his letter, “... Kona coffee blending requirements remains an important issue. It would be unfortunate if this issue is again sidelined due to funding limitations and the high funding hurdle suggested by the previous proposals. This need not be the case. While the market research aspects of the earlier proposals are interesting, they are not essential to answering the

fundamental question posed by the Legislature in SCR 102--how alternative blending and labeling requirements would affect Hawaii growers and the state economy.

My company, Resource Decisions could perform a much simpler supply and demand study that would be targeted on the policy-relevant issues facing the Legislature, notably how alternative minimum blending limitations would affect the quantity of Kona coffee sold, the price received by growers, and the effects on State revenues.”

The State’s response was “Unfortunately, the current economic climate precludes any such assessment being undertaken with State funds in the near future.”

Time for new leadership at the top? Which brings us to our next article....

Neil Abercrombie supports Truth-in-Labeling

Back in our May newsletter we reported that the KCFA had sent a letter urging that as part of the gubernatorial campaign’s “agenda for change” there be a commitment to “fix the fraud” (Sen. Clayton Hee’s words) of the current coffee blend labeling laws.

We are delighted to report his response, verbatim, from an email from his Deputy Campaign Manager, Andrew Aoki – “Just got off the phone with Neil. He’s totally on board and is certain that we can work out the details to get truth-in-labeling when he becomes Governor. Hawaii Coffee Company caught in False Labeling

Found on the shelves at Kona Walmart (and presumably many others) a package of “Gourmet Hawaiian Coffee”, produced by the Hawaii Coffee Company, HCC, of Honolulu. On the front in large type it says “Hawaiian Coffee”. On the back “Each Hawaiian island produces an extraordinary coffee that has its own special flavor. These unique semi-tropical islands provide rich volcanic soil, mild trade winds, cool gentle rains, and afternoon shade, to create ideal coffee growing conditions.” BUT, what do you get when you open the package? Three small packets of Lion brand “International Coffee Blend” and nothing to say there is even a bean of Hawaiian coffee inside!!!

How many meetings have Kona coffee growers attended where Jim Wayman of HCC has pounded the table and said how “honest” his company is in obeying the existing (and disastrously flawed) labeling laws? Well, Jim !?!?...

KCFA’s persistent and constant emails to the Quality Assurance division of the HDoA finally brought the message that HCC had submitted changes to the packages and these had been approved. No word of any penalty, or of whether they were asked to remove the illegal packages from the shelf while redesigning their packages.

These massive corporations have no interest in the reputation of Kona coffee, only in their own profits, and obviously are willing to ignore the existing labeling laws. Time for some laws that have REAL teeth to help protect our gourmet product.

Remember - Coffee for Your Memory!

Scientists have uncovered powerful evidence that caffeine not only helps to stave off Alzheimer's but can treat it. A team from the Florida Alzheimer's Disease Research Centre in Tampa gave caffeine to elderly mice showing memory impairment. After two months the mice performed better on memory tests than mice not given the caffeine. The equivalent dose for humans would be two cups of strong coffee a day. But there is no evidence that the caffeine boosts the memory of healthy young brains, so you can't store it up for the future.
